



The Company during CIRP period under Insolvency & Bankruptcy Code 2016 through Mr Ravi Sethia, Chairman - Monitoring Committee (formed as per Resolution Plan vide NCLT Order dated 19.12.2023), had filed an Interlocutory Application with Hon'ble NCLT Kolkata Bench vide filing No.1908134/03987/2024 dated 01.10.2024 seeking direction against Stock Exchanges regarding waiver of SOP fines and penalties levied. The outstanding SOP Fines are the subject matter of proceedings pending before the Hon'ble NCLT, and the matter was last heard by NCLT on 12.03.2025 and next hearing date is 23.04.2025. **Hence, the matter is sub-judice.**

**At this juncture, the Exchange is requested to neither initiate any adverse action against the Company nor levy SOP fines considering the best interests of the Company.**
